The MBE is a six-hour, 200-question multiple-choice examination developed by the National Conference of Bar Examiners (NCBE) and administered by participating jurisdictions, including Florida, on the last Wednesday in February and July of each year.

The Florida Bar Exam assesses whether or not a candidate is competent to practice law in Florida. The exam is comprised of two parts - the Multistate Bar Exam (MBE) and the state-specific essay portion. A minimum scaled score of 272 out of 400 possible points is required to pass.
