In Uniform Bar Exam jurisdictions, all you need to do is divide the score you need to pass by 2. So, New York’s passing bar exam score is 266. $266/2$ is 133. Therefore, a 133 is a “passing” MBE score in New York. Now, the UBE does allow you to pass by scoring higher on one portion or another.

Percentage of MBE questions to pass the MBE? - JD Advising

If you are aiming for an MBE score of 136-140 (which is a passing MBE score in jurisdictions that require a 272-280 to pass) you should aim for 62%-65%. If you are aiming for an MBE score of 144 (which is considered passing in California), you should aim for about 67%.
