If you refused to provide a chemical sample, or if you took a breath test with a result of .08 or greater (or .02 or greater for a minor), the officer will serve you with an Express Consent Affidavit and Notice of Revocation after all paperwork has been completed. This form says you have up to 7 days after your arrest to request a hearing, if you choose to do so.
