The Division of Regulated Child Care is responsible for licensing and investigating complaints against licensed child care facilities, certified family child care homes, residential child caring facilities and child placing agencies.

Regulation of health care in England comprises two main elements: regulation of the quality and safety of care offered by health care providers, currently undertaken by the Care Quality Commission (CQC), and regulation of the market in health care services, currently the responsibility of Monitor (in relation to foundation trusts) and the Department of Health.

THE NATURE OF HEALTH CARE REGULATION The pervasive nature of health care regulation stems from the fundamental concerns that are at stake. Most observers acknowledge that some form of oversight is needed when factors as essential as life and health are involved.

Why Is Health Care Regulation So Complex?

Health care regulations are developed and implemented not only by all levels of government (federal, state and local) but by private organizations as well. Health care regulations and standards are necessary to ensure compliance and to provide safe health care to every individual who accesses the system.

Child Care Regulations

Child care licensing regulations cover many topics, including the following: The number of children one adult can care for at a time (child-staff ratio) and the number of children allowed in a class (group size) Supervision of children. Safety of the building (such as emergency exits, cleanliness and repairs, and potential dangers)

These Regulations set out matters to which a local authority must have regard when carrying out its duty under section 38(1) of the Care Act 2014 ("the Act"). Sections 37 and 38 of the Act set out procedures to be followed when an individual who is receiving care and support from a local authority ("the first authority") wishes to move to the area of another local authority ("the second authority").
